PRELIMINARY REPORT

**AMERICAN LAND TITLE ASSOCIATION

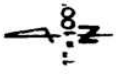

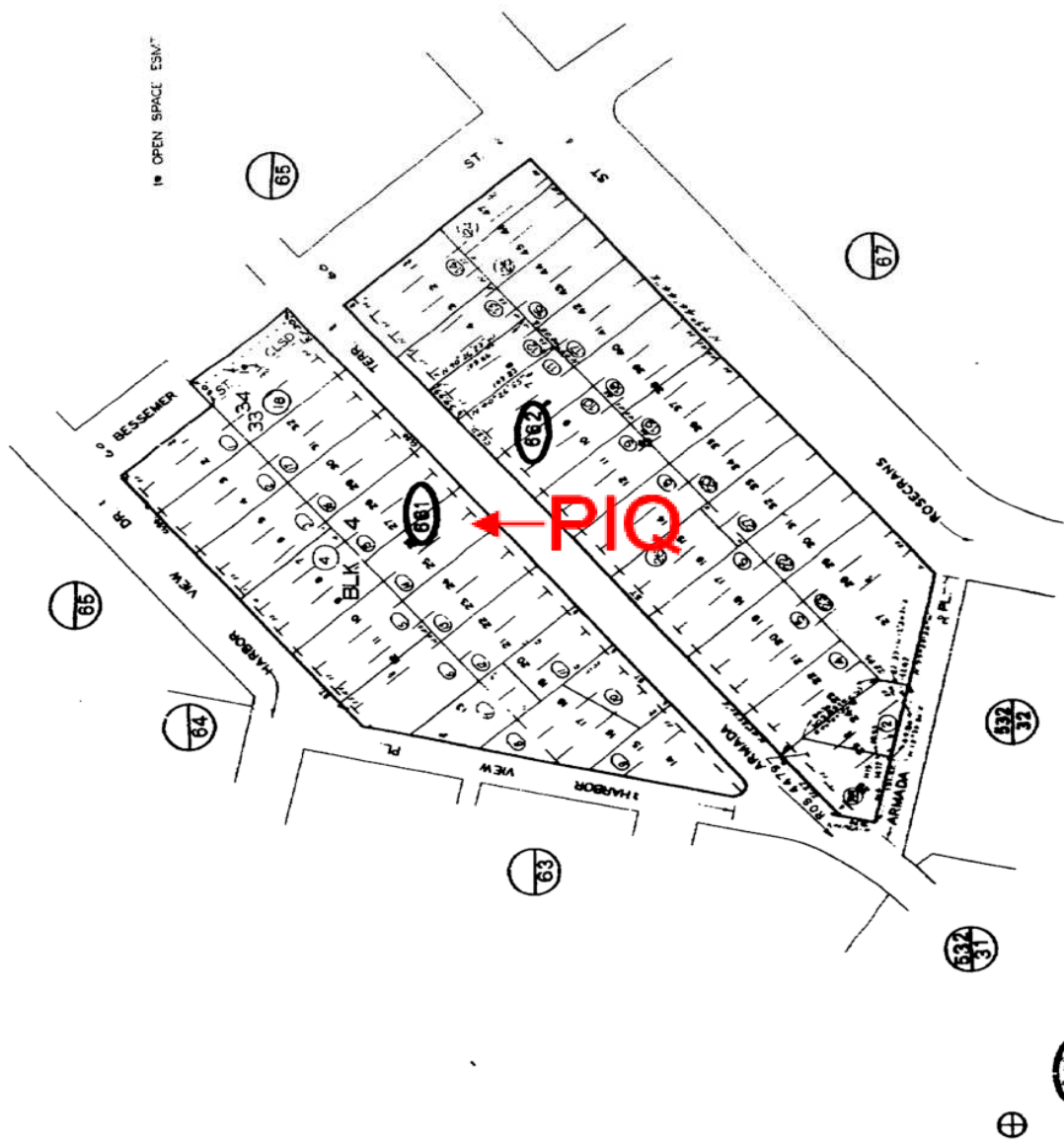
