DIRECTIONS: From Interstate 5: Exit Lomas Santa Fe and go east for approximately 1 mile. Turn right at Sun Valley Road and take first right on Paso Del Sol. Follow approximately 1/3 mile to end of road then enter private driveway at 15005 Paso Del Sol.
